In view of UGC (Academic Collaboration between Indian and Foreign Higher Educational Institutions to offer Twinning, Joint Degree and Dual DegreeProgrammes) Regulations2022, Hon'ble Vice Chancellor of Dr. Harisingh Gour Vishwavidyalaya, Prof. Neelima Gupta, visited Spain as Governing Council member of the Association of Indian Universities. The delegation of the AIU participated in the Contact Seminar organized in Spain from 8 to 11 July 2024 to foster collaboration between Indian and Spanish universities and visited five universities of Barcelona, Madrid and Valladolid, which are as follows:

- Autonomous University of Barcelona (AUB)
- University of Barcelona
- IE University, Madrid
- Autonomous University of Madrid
- University of Valladolid

In this seminar, meaningful discussions were held on topics like academic and research partnership, mutual cooperation, student and faculty exchange with various Universities of Spain, the Govt. of Catolina, SEPIE and CRUE.

Furthermore, the team discussed further prospects for collaborations, Twinning Programme, Joint Degree Programme, Dual Degree Programme between India and Spain with various stakeholders of Spanish Universities and Shri Dinesh K. Patnaik, Ambassador of India in Spain.

In light of NEP 2020, the Council has developed the Integrated Special & Inclusive Teacher Education Programme (ISITEP) which will be implemented from the academic session 2024-25 on a pilot basis.

In view of the above, the Department of Education on behalf of the University, already sent their expression of interest to the Council to begin ISITEP from the academic session 2024-25.
