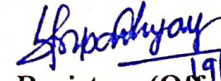

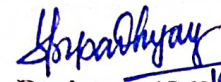

MINUTES OF THE 7th SPECIAL MEETING OF THE ACADEMIC COUNCIL (AC)

- Date : 19th June, 2025
- Time : 11:00 A.M.
- Venue : Blended Mode / Gour Samiti Kaksha, Dr. Harisingh Gour Vishwavidyalaya.

At the outset, the Director of Academic Affairs, Prof. Naveen Kango extended a warm welcome to the Hon'ble Vice-Chancellor and Chairperson of the Academic Council Prof. Neelima Gupta, and also welcomed all the esteemed members of the AC.

Thereafter, the Chairperson Prof. Neelima Gupta extended a cordial welcome to all the AC members especially the external members who joined the meeting through online mode viz. Prof. Sangeeta Shukla, Hon'ble Vice Chancellor, Chaudhary Charan Singh University, Meerut, Prof. R.N. Yadava, Former Vice Chancellor, Purnea University, Purnea, Prof. A.P. Singh, Director General, Raja Rammohun Roy Library Foundation, Kolkata, Prof. Pawan Poddar, Hon'ble Vice Chancellor, Binod Bihari Mahto Koyalanchal Univeristy, Dhanbad, Dr. Sanjeev K. Varshney, Former Advisor, International Cooperation Department, DST, New Delhi and Prof. Ashok Mittal, Former Vice Chancellor, Bhimao Ambedkar University, Agra. The Chairperson also welcomed all Dean of Schools, all Heads of Teaching Departments, newly appointed members and Students' representatives of the Academic Council. All the members also extended a warm welcome to the Chairperson. **The list of members present in the meeting and leave of absence is annexed with the Minutes.**

The Chairperson briefed about this meeting specially convened in connection with the 33rd Convocation of the Vishwavidyalaya (Seventh convocation after attaining the status of Central University in the year 2009), scheduled on Friday, 20th June, 2025. It is informed to the Council that the University Administration has made constant efforts to have the consent of distinguished personalities in order of precedence, to be invited as Chief Guest for the Convocation and to deliver the Convocation address. Shri Nitin Jairam Gadkari, Hon'ble Minister of Road Transport & Highways, Govt. of India has kindly consented to grace the 33rd Convocation as Chief Guest and to deliver the Convocation address and Shri Rajendra Shukla, Hon'ble Deputy Chief Minister of Madhya Pradesh as Special Guest. Shri Govind Singh Rajput, Hon'ble Minister for Food, Civil Supplies and Consumer Protection of Madhya Pradesh and Dr. Lata Wankhede, Hon'ble Member of Parliament, Sagar Madhya Pradesh shall be the Gour Atithi. The Chairperson also informed the Council that Padam Vibhushan Shri Raghavveeyo Jagadguru Swami Rambhadracharya will be conferred with the Honorary Degree during the Convocation.

The Chairperson also highlighted important academic development that took place in the Vishwavidyalaya in the recent past.

Thereafter, Agenda items were taken for discussion. The Registrar (Offg.) and Secretary of the Academic Council Dr. Satya Prakash Upadhyay read out the agenda items.

AC-ITEM NO. (i) 33rd Convocation of the Vishwavidyalaya.

It is informed that all the Graduates and Post Graduates (Regular Candidates) who have passed-out under the Choice Based Credit System (CBCS) and National Education Policy 2020 in Academic Session 2023-24 and those candidates who have qualified for the award of Ph.D. Degree after 29.02.2024 shall be eligible for conferment of Degree. Accordingly, online applications were invited from 21.12.2024 to 20.01.2025 and from 16.04.2025 to 20.04.2025 with a non-refundable Registration Fee of Rs. 1000.00 (Rs. One Thousand only) to attend the Convocation in person and Rs. 600.00 (Rs. Six Hundred only) *in absentia*. The break-up of the candidates enrolled for conferment of Degree is as follows:

The Council further conveyed its best wishes for the successful organization of the Convocation ceremony.

AC-ITEM NO.(ii) To confer Honorary Degree to Shri Raghaveeyo Jagadguru Swami Rambhadracharya in the 33rd Convocation of the Vishwavidyalaya.

A recommendation of Honorary Degree Committee recommending the name of Padam Vibhushan Shri Raghaveeyo Jagadguru Swami Rambhadracharya for conferring the Honorary Degree by the Vishwavidyalaya in the ensuing 33rd Convocation of the Vishwavidyalaya was placed before the Executive Council in its meeting dated 30th December, 2024.

It was resolved by the Executive Council to forward the proposal to the Hon'ble Visitor for approval. Subsequently, the Hon'ble Visitor was pleased to approve the proposal.

It is informed to the Council that Shri Raghaveeyo Jagadguru Swami Rambhadracharya is the founder and head of Tulsi Peeth, a religious and social service institution in Chitrakoot named after Saint Tulsidas. He is the founder and Lifelong Chancellor of the Jagadguru Ramabhadracharya Divyang Rajya Vishwavidyalaya, Chitrakoot (U.P.) which offers graduate and postgraduate courses exclusively to four types of disabled students. He has authored more than 240 books and 50 papers including 4 epics, Hindi commentaries on Tulsidas' Ramcharitmanas and Hanuman Chalisa. He is acknowledged for his knowledge in diverse fields including Sanskrit Grammar, NyayaP, and Vedanta. He is regarded as one of the greatest authorities on Tulsidas in India and is the editor of a critical edition of the Ramcharitmanas. In 2021, he was also awarded the Sahitya Academy Fellowship. He is the recipient of the 58th Jnanpith Award for 2023.
