Prof. Vinod Kumar Bhardwaj, DoAA, extended a warm welcome to the Chairperson and all esteemed members of the APC. Thereafter, the agenda items were taken up for discussion.

#### To consider the proposal for Conversion of Vacant Reserved Category Seats to APC:EM:57:01 Unreserved Category Seats in MBA Programmes for the current academic session.

The Head, Dept. of Business Management has proposed the conversion of vacant reserved category seats to unreserved category seats in various MBA programmes. Most of MBA programs currently operate on a self-finance mode. In order to support the department's expansion and development, additional funding is essential. If this proposal is approved, the generated funds shall be deposited into the designated selffinance account. Further, the department will utilize this opportunity to admit eligible candidates who were previously unable to secure admission due to limited capacity. The Chief Coordinator, Admission Cell has recommended that the matter may be

placed for detailed discussion and consideration in the APC meeting.

Along with the above agenda item, the Dean, School of Law, also proposed the filling of vacant seats, upon completion of admission process, in UG & PG programmes offered by Dept. of Law.

The APC after due deliberation resolved to approve the filling of vacant reserved category seats under the General Category, in accordance with the provisions contained in the Amended Ordinance-44 of the Vishwavidyalaya, following due admission process.

It was further resolved that the provisions of the said Ordinance shall be incorporated into the Admission Brochure of the Vishwavidyalaya from Academic Session 2026-27 onwards.

A notification to this effect be uploaded in University Website and also the fee of the students admitted be refunded by the Institute of Distance Education, if any.

The matter pertains to allowing Ph.D. scholars who have secured employment in Government/Semi-Government organizations to complete their Ph.D. work, although they have not completed the minimum three-year duration of the programme.

In accordance with the resolutions passed in the 55<sup>th</sup> Emergent Meeting of APC dated 01.05.2025 under Agenda Item No. APC: EM:55:08, Ph.D. Scholar who has completed a



minimum of Two Years of residential period and has obtained Regular/Full-time Employment in a Government/Semi-Government Organization/ Institution may be allowed to complete his/her Ph.D. degree provided that he/she fulfills the following conditions: -

- i. The candidate will complete minimum duration as prescribed by the UGC.
- ii. Produces a No Objection Certificate (NOC) from the Employer for completion of Ph.D. Degree indicating that he/she will be relieved for the purpose.
- iii. Fulfills the rest of the conditions, including minimum/maximum duration of Ph.D. Program and all other conditions as per the UGC Regulations and Ph.D. Ordinance of the Vishwavidyalaya.
- iv. During this period, the Ph.D. Scholar will not be eligible for any financial support (Fellowship/Contingency etc.) from the Vishwavidyalaya.

In view of the said resolution, following Ph.D. scholars who have secured employment in Government/ Semi-Government organizations, have made representations through their Departmental Research Committees to complete their Ph.D. programme:

If a Ph. D. scholar takes an employment without completing the minimum residence requirement i.e. 3 years.

- i. The candidate will complete minimum duration as prescribed by the UGC.
- ii. Produces a No Objection Certificate (NOC) from the Employer for completion of Ph.D. Degree indicating that he/she will be relieved for the purpose.
- iii. Fulfills the rest of the conditions, including minimum/maximum duration of Ph.D. Program and all other conditions as per the UGC Regulations and Ph.D. Ordinance of the Vishwavidyalaya.
- iv. During this period, the Ph.D. Scholar will not be eligible for any financial support (Fellowship/Contingency etc.) from the Vishwavidyalaya.

The matter pertains to the requirement of Teachers, in the Dept. of Law and the report of the committee constituted to consider the requirement of Bar Council of India for Law Courses in respect of Teaching Load and Teachers *vis-à-vis* vacant teaching position in the Dept. of Law, and suggest a viable solution.

The Head of the Department of Law informed the DoFA Section regarding the teaching load and the need for additional teaching staff. In response, a committee was constituted vide office order No./DoFA/2025/621 dated 18<sup>th</sup> August 2025, to consider the requirement of Bar Council of India for Law Courses in respect of teaching load and Teachers vis-à-vis vacant teaching position in the Dept. of Law, and to suggest a viable solution.

Following an in-depth review, the committee submitted its report to the DoFA Section. Upon careful examination of the committee's recommendations, in terms of the extant rule position, the DoFA Section proposed appointments of Three Contractual Assistant Professors and Two Guest Faculty Teachers, to meet the workload in the Dept. of Law.

Resolution:

The APC after due deliberation resolved to approve the proposal for appointment of Three Contractual Assistant Professor on fixed emolument of Rs. 57,700/- plus DA (as applicable), for one Academic Session and performance of any such entrant teachers should be reviewed for academic performance before reappointing him/her on a contract basis for another session. However, such appointments and re-appointments may not exceed three Academic Sessions.

The APC Further resolved to engage Two Guest Faculty as per guidelines of UGC to meet the teaching workload in the Dept. of Law. These positions will carry emoluments, as per applicable rules.

All above appointments, whether contractual or guest faculty, shall be subject to financial concurrence. (Action: DoFA)

Engagement of Contractual Faculty in the Dept. of Business Management.

Upon consideration of the AICTE report (vide F.No. Central/1-44642551536/2025/EOA dated 20<sup>th</sup> March 2025) indicating faculty deficiency in the Department of Business Management, along with the recommendations of Head, Dept. of Business Management and in terms of the extant rule position, the DoFA Section proposed to advertise Six Assistant Professors on contract basis for one academic session on the emoluments of Rs. 57,700/- plus DA (as applicable), to meet the workload in the Dept. of Business Management. The performance of any such entrant teachers should be reviewed for academic performance before reappointing him/her on a contract basis for another session.
