While discussing the recommendation of the Selection Committee in respect of the promotion of Dr. Kalinath Jha, Dept. of Sociology, to the post of Professor in the Academic Pay Level-14 under CAS, it was brought to the notice of the Council that the confirmation of Dr. Kalinath Jha to the post of Associate Professor is subject to the final outcome of WP No.16254/2014 and the case is still pending. The reply has already been filed by the University supporting the case of Dr. Kalinath Jha. The case was last listed on 13-10-2017. EC-XXXI- Extending the time limit for conducting recruitment against Advt.No.RA-(III)-(ii): NT/2023/01 dated 04.02.2023 for 141 Non-teaching positions.

It is informed to the Council that the Vishwavidyalaya vide Advt. No.RA-NT/2023/01 dated 04.02.2023 advertised 141 Non-teaching positions. The screening of the applications received against 14 Group-A posts has already been carried out. However, the interview for the said positions could not be conducted for want of nomination of EC Member. Further, the written examination for Group-B&C posts (04 Cadres) and the Screening Test for the posts of Assistant Registrar are to be conducted by the National Testing Agency (NTA) in the first week of August 2023. After the declaration of the result of the written test, the skills test of qualified candidates is to be conducted by the University and it will take time to conclude the entire recruitment process. As per the CRRs 2022 based on Model Cadre Recruitment Rules circulated by the UGC vide letter dated 27.09.2022 duly approved by the Executive Council, the University may ensure that the entire recruitment process including starting from advertisement, conducting a written examination or holding the interview may be completed within six months. (Ref: DoPT O.M. N.Misc.14017/15/2015-Estt.(RR) dated 11.01.2016 duly forwarded by UGC to all central Universities vide letter No.F74-1/2017 (CU) dated 16 October 2017). Provided that, if in the opinion of the Vice-Chancellor, the circumstances so warrant, he/she may extend the time limit for the recruitment process by a maximum period of six months. For the reasons stated herein above, it is proposed to extend the time limit for a period of six months i.e. upto 03.02.2024 for conducting the recruitment process for these Non-Teaching positions.

EC-XXXI-(III)-(iii): Extending the time limit for conducting recruitment against Advertisement No.R/DoFA/Associate Professor 2023/ 2416 dated 22.02.2023 and Advertisement No.R/DoFA/Professor/2023/2417 dated 22.02.2023 for 93 positions of Associate Professor and 54 positions of Professor.

It is informed to the Council that the Vishwavidyalaya vide Advt.No. R/DoFA/ Associate Professor 2023/2416 dated 22.02.2023 and Advertisement No.R/DoFA/Professor/2023/2417 dated 22.02.2023 invited applications for appointment to 93 positions of Associate Professor in 36 disciplines and 54 positions of Professors in 31 disciplines. The screening process for applications received against some of these disciplines has been carried out and interviews have also been scheduled. However, the screening of a sizeable number of applications is in process and if conducted will take time to conclude the entire recruitment process due to consuming much time to verify the Academic/ Research Score claimed by the candidates. As per DoPT O.M. N.Misc.14017/15/2015-Estt.(RR) dated 11.01.2016 duly forwarded by UGC to all Central Universities vide letter No.F74-1/2017 (CU) dated 16 October 2017, the entire recruitment process including starting from advertisement, conducting a written examination, or holding the interview may be completed within six months. For the reasons stated herein above, it is proposed to extend the time limit for a period of six months i.e. upto 21.02.2024 for conducting the recruitment process for these Teaching positions.

Resolution: The Council after due deliberations unanimously resolved to approve the proposal under the captioned agenda.

EC-XXXI-(III)-(iv): Nomination of One Member of the Executive Council on the Selection Committees for the Group-A Posts (other than Statutory posts and those covered under UGC Regulations.)

It is informed to the Council that as per the CRRs 2022 based on Model Cadre Recruitment Rules circulated by the UGC vide letter dated 27.09.2022 duly approved by the Executive Council, there shall be one member of the EC nominated by it as a member of the Selection Committees for Group-A posts (other than statutory posts and those covered under UGC).

The Council further resolved to authorize the Vice-Chancellor to nominate any other member on the Selection Committee, if the nominated member is not available on the date of the Selection Committee for any reason.

EC-XXXI-(III)-(v):

Extension in term of Director, EMMRC, Dr. Pankaj Tiwari.

It is informed to the Council that an application was received from Dr. Pankaj Tiwari, Director, EMMRC, for an extension of his term expiring on 11.04.2023. Under the provision of the Clause B.3 of the Staffing Pattern dated 06.06.1996 issued by UGC for the Media Centers, the posts of Director and Joint Director of Media Centre shall be extendable to another term (s) up to the age of 60 years. Further, as per the decision of the 11th Board of Management Meeting held on 1st April 2018, the Director may be appointed for a tenure of 5 years extendable to another term (s) up to the age of 60 years.

The request of Dr. Pankaj Tiwari was placed before the BOM in its 15th Meeting held on 06.04.2023 for consideration and the Board of Management (BOM) unanimously resolved to constitute a Committee (Committee consisting of Prof. J.B. Nadda, Director, CEC, New Delhi, Dr. Akhlesh Singh, Vice-Chancellor, Rajju Bhaiya University, Prayagraj and Prof. H.Thomas, Director Research & Development, Dr. Harisingh Gour Vishwavidyalaya, Sagar) to examine the issue and the recommendation of the Committee so constituted will be placed before the BoM for consideration, The BoM further resolved that meanwhile, Dr. Pankaj Tiwari will continue as Director, EMMRC.

The Committee so constituted had a detailed discussion on 01.05.2023 on available Self-appraisal Reports/Annual Performance Assessment Reports (APARs) of the last 05 years, Annual reports of EMMRC Sagar, and an application with year-wise performance reports. Also, there is no vigilance/ Disciplinary case either pending or contemplated against him as per available records. In the light of available records, reports, and the discussion, the Committee found that the performance of Dr. Pankaj Tiwari, as Director, EMMRC is excellent. Therefore, on the basis of assessment, as indicated above, the Committee recommends that the term of Dr. Pankaj Tiwari as Director, EMMRC may be extended to another term of five years.

The recommendation of the Committee was circulated to all the Members of BoM through e-mail on 16.05.2023 for consideration. The Members conveyed their approval through the mail.

Resolution: The Council after due deliberations resolved to approve the extension of Dr. Pankaj Tiwari as Director, EMMRC for another term of five years.

EC-XXXI-(III)-(vi):

Representation dated 24.03.2023 of Prof. Ganesh Shankar Giri (Now retired) in respect of the resolution passed by the Executive Council in its

30th Meeting regarding his promotion from AL-14 to AL-15.

It is informed to the Council that it was brought to the notice of the Council in its 30th meeting held on 11.03.2023 while discussing the recommendation of the Selection Committee in respect of the promotion of Prof. Ganesh Shankar Giri, Dept. of Yoga Education to the post of Senior Professor in the Academic Pay Level-15 under CAS, that Prof. Ganesh Shankar Giri, retired from the services of the Vishwavidyalaya on 28.02.2023, whereas, on the date of consideration by the Selection Committee on 21.02.2023, he was in the active service of the Vishwavidyalaya. After due deliberations, the EC resolved to seek clarification from UGC in this regard and after receipt of the clarification, the recommendation in respect of the promotion of Prof. Giri may be placed again in the EC for consideration. Through the referred representation, Prof. Giri has submitted that he fulfills both the requirements as per clause 6.3 (V) and (VI) (ii) of the UGC Regulations 2018, and these points are very much clear as under:

- He retired from the University service on 28.02.2023 and he was in active service of the University on the date of consideration by the Selection Committee i.e. on 21.02.2023 (as per UGC Regulations 2018 clause No.6.3 (V).
- ii) He has published 10 papers till Dec.2021 as per CAS promotion Criteria of the UGC Regulations 6.3 (VI) (ii).

With these submissions, he has requested to rectify the recommendations stated in the Minutes of the 30 EC with regard to his CAS Promotion from AL-14 to AL-15.

Resolution: The Council after due deliberations resolved to approve the recommendation of the Selection Committee for the promotion of Prof. Ganesh Shankar Giri to the post of Senior Professor under the Career Advancement Scheme (CAS) of the UGC:

EC-XXXI-(III)-(vii): To consider the case of Dr. Aleem Ahmad Khan for a grant of Rs.7000/- and 8000/- in compliance with the order dated 10.02.2023 passed by the Hon'ble High Court of MP at Jabalpur in WP No. 3243 of 2017.

The Hon'ble High Court of MP at Jabalpur vide its order dated 10.02.2023 in WP No. 3243 of 2017, Dr. Aleem Khan Vs Dr. Harisingh Gour Vishwavidyalaya, Sagar, and others, has directed to consider the case of the Petitioner for grant of AGP of Rs 7000/- and 8000/- respectively on completion of 4 years of service in the Grade Pay Rs 6000/- and 5 years of service in the Grade Pay of Rs 7000/- as per the Guidelines of the UGC. It is informed to the Council that the Petitioner Dr. Aleem Ahamad Khan was

appointed initially as a Lecturer in the Dept. of Journalism of the Vishwavidyalaya on 19.07.1999 on the recommendation of the Selection Committee. However, his appointment as Lecturer made on 19.07.1999 was declared null and void by the Hon'ble Chancellor of the Vishwavidyalaya vide order dated 27.09.2001 in the exercise of his power conferred under Section 12 (4) (Ka) of the MP Vishwavidyalaya Adhiniyam 1973 on the ground that he did not fulfill the eligibility criteria prescribed for the post of Lecturer at that time. However, he (Dr. Aleem Ahamad Khan) assailed the aforesaid order of the Hon'ble Chancellor before the Hon'ble High Court of the MP at Jabalpur by way of WP No. 4975/2001 and obtained a stay order in his favour vide order dated 03.10.2001. Since then he was continuing in service on the basis of the aforesaid interim order of the Hon'ble High Court. During the pendency of the said petition, he applied for the post of Associate Professor in the Department of Journalism against the Rolling Advt. dated 30.10.2010. However, on the recommendation of the Selection Committee, he was given an appointment on 16.09.2013 as Assistant Professor, Stage-III. Although his pay fixation was done in the AGP of Rs 8000/- on his fresh appointment in the year 2013 as Assistant Professor Stage-III yet implementation of the pay fixation order could not be given effect and he continued to draw his salary in AGP Rs 6000/-. In between, the UGC vide its letter F.21-2/2016 (CU) dated 28.10.2016 communicated to this Vishwavidyalaya that the University has awarded a higher AGP of Rs 7000 to 8000/- to a certain Assistant Professors at the time of the appointment which is not permissible as per UGC Regulations 2010. Therefore, it is requested to withdraw the higher AGP given to the Assistant professors and make a recovery from the salary of the concerned teachers. It is also to inform that UGC is now constrained to withhold an amount of Rs. 1.00 crore from the maintenance grant of the University till the corrective measures are taken by the University. A compliance report may be sent to UGC within a month. The aforesaid communication for the UGC was placed before the Executive Council in its 20th meeting dated 07.12.2016 for consideration and the Council after due deliberations resolved to refer the case of the petitioner to UGC for review in view of the fact that he applied for the post of Associate Professor and Executive Council on the recommendation of the Selection Committee appointed him in the post of Assistant Professor Stage-III. In pursuance of the aforesaid resolution of the Executive Council, a letter bearing no. R/DoFA/437 dated 15.02.2017 was sent to the UGC and the response of the UGC on the said letter is still awaited. However, the Writ Petition No. 4975/2001, through which his earlier service as Lecturer (re-designated as Assistant Professor w.e.f. 01.01.2006) was continuing has been dismissed as withdrawn vide order dated 06.03.2014. The petitioner filed a fresh petition bearing WP No. 3243 of 2017 to extend the pay of AGP Rs 8000/- in which he was given an appointment on 16.09.2013. The Hon'ble Court after hearing all the parties has passed the order on 10.02.2023 directing the authorities of the Vishwavidyalaya and UGC to consider the case of the petitioner Dr. Aleem Ahamad Khan for grant of AGP 7000 and 8000/- respectively on completion of 4 years service in the Grade Pay Rs 6000/- and 5 years of service in the Grade Pay of Rs 7000/- as per the guidelines of the UGC.

EC-XXXI-(III)-(viii): To consider an amendment in the Ph.D. Ordinance 23 (A) (Admission, Examination, and Evaluation for the award of Doctor of Philosophy) according to UGC Regulations 2022 as published in the Gazette of India dated 07 November 2022.

Consequent upon the adoption of the UGC (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2022 by the Executive Council of the Vishwavidyalaya in its 29th Meeting held on 20 December 2022, amendment in Ordinance 23 (A) is required.

A draft of the amendment in Ordinance 23 (A) was placed before the Academic Council in its 18th Meeting held on 12-07-2023 and the Academic Council after due deliberations resolved to pass the proposed amendment.

Resolution: The Council after due deliberations resolved to approve the Amendments made in Ordinance 23(A) and to adopt the same. The Council further resolved to submit the Amended Ordinance to the Hon'ble Visitor in terms of Statute 37(6) of the Statutes contained in the Second Schedule of Central Universities Act, 2009.

EC-XXXI-(III)-(ix):

To revisit the resolution passed by the Executive Council in its 23rd Meeting held on 24-01-2019 regarding age relaxation and earmarking of 40% vacant posts of Group-C for Daily Wage Employees, Muster Roll, and Temporary Employees, as a one-time measure.

It is informed to the Council that the Council in its 23rd Meeting held 24-01-2019, after detailed deliberations, unanimously resolved to approve the recommendation of the CRR Committee to allow age relaxation to the Daily Wage/Muster Roll/ Temporary Employees, as a one-time measure, to the extent of period of service rendered by them in the Vishwavidyalaya to enable them to appear along with other candidates in the regular examinations conducted by the Vishwavidyalaya for recruitment to Group-C posts.

Further, the Chairperson drew the attention of the esteemed members on the observation of the UGC Rationalization Committee on the issue of Regularization of Daily Wage Employees that the University should devise an internal mechanism with the approval of its EC to address their grievances, keeping in view their long years of service without break. The Committee also expressed its concern that the University has been incurring expenses to the tune of crores of rupees due to the payment of graded salaries to these employees who have been working without any sanctioned posts. It is informed to the Council that these categories of employees are being paid a minimum of the graded salary plus DA in pursuance of the order dated 26.09.2011 passed by the Hon'ble High Court of MP in WP No. 4460/2010 which was upheld by the Supreme Court vide order dated 26.07.2013 (SLP No. 18342-18343 of 2013).

After taking into account all these facts, the Council unanimously resolved to earmark 40% of vacant posts of Group-C only for these categories of employees, as a one-time measure. The eligible candidates from such category of employees will appear in the written test to be conducted for recruitment for 40% of the vacant posts of Group-C and on the basis of their performance in the written test and skill test, if applicable, the successful candidate may be given regular appointment. The remaining vacant positions of Group-C shall be open for all and recruitment of these vacant posts shall be made on the basis of a written test conducted on an All India basis and skill test, if applicable. However, in subsequent recruitments, only 10% of vacant posts of Group-C will be earmarked for these categories of employees upto five years and the remaining vacant posts will be filled up through a written test to be conducted on an All India basis. The reservation rules of Govt. of India, as applicable, will be applied in both the aforesaid appointments.

In this regard, it is also informed to the Council that in pursuance of the aforesaid resolution of the EC, the Vishwavidyalaya made an internal advertisement earmarking 40% of vacant seats of Group-C posts for these categories of employees in the year 2019. However, the recruitment process could not be concluded. The Vishwavidyalaya vide Advt. No.RA-NT/2023/01 dated 04.02.2023 advertised 141 Non-teaching positions and the recruitment process is underway. The remaining 40% of vacant seats of Group-C posts are kept on hold.

Resolution:

The Council after due deliberations resolved that as now CRRs 2022 have been duly adopted by the EC and as such the remaining vacant Group C Posts be advertised as per CRRs 2022.

EC-XXXI-(III)-(x): To consider the representation for appointment of Assistant Professors in the College of Paramedical Science under the UR category.

Dr. Ishan Pandey, Dr. Hemant Kumar Rawat, and Dr. Karthikeya Tiwari were appointed as Assistant Professors in the College of Paramedical Sciences under the UR category on the recommendation of the Selection Committee approved by the Executive Council in its Meeting held on 11-03-2023. Some representations were received for these appointments and the appointed candidates have requested to release their appointment letter justifying the case along with relevant proofs.

Resolution:

The Council after due deliberations resolved to issue an appointment order to the selected candidates who have a valid registration with the concerned Council and the registration certificate along with documents supporting their eligibility has been attached by them to their application forms. The candidates who have not attached a valid registration certificate with the concerned Council along with documents supporting their eligibility may be given an opportunity to submit the same within a period of 15 days from the issue of the letter. If they fail to submit the requisite documents within the stipulated period, their claim for appointment may be forfeited.

With the permission of Chair Prof. P.K. Kathal, Director of Faculty Affairs, a special invitee to this meeting raised the issue of counting of teaching experience of the Assistant Professors appointed in the year 2013 against the Rolling Advertisement dated 30-10-2010 for the posts of Associate Professor/ Professor against the advertisement dated 22-02-2023. He also read out the eligibility criteria mentioned in the UGC Regulations 2018 for the posts of Associate Professor and Professor and the provisions contained in clause 10 of UGC Regulations 2018 on counting of past services for direct recruitment and promotion under CAS. He further submitted that out of these Assistant Professors, a sizeable number of Assistant Professors have been appointed as Associate Professors & Professors in other Central Universities and Institutes of National importance on the basis of the teaching experience of this University.

Resolution:

The Council after due deliberations resolved to count the teaching experience of these teachers for the posts of Associate Professors/ Professors against the Advertisement dated 22/02/2023 in terms of clause 10 of UGC Regulations 2018. In the event of Selection, his/her appointment will be subject to the outcome of the court case(s) pending, if any, and directives of the Ministry of Education/UGC.
