Pre-Ph. D. Course Work

A General Introduction to the Programme:

The student admitted to the Ph.D. Programme shall be required to undertake the Pre-Ph.D. Course Work in the First semester. The Course Work shall consist of Four Core Papers out of which three would be of 4 credits each and one will be of 2 credits. The student shall also be required to select one Elective Paper out of the options provided. The Elective paper shall be of 4 credits. The student will thus be required to undertake a minimum of 18 credits during the First Semester.

Scheme of Examination

All Programs of Studies of the University follow the Semester system and examination and evaluation of students is through Comprehensive Continuous Internal Assessment (CCA). The Semester Examination shall comprise of the following Components:

(a) Mid Semester Examination
 (b) Internal Assessment
 (c) End Semester Examination
 (d) Marks
 (e) End Semester Examination

Note: To be eligible to appear in the End Semester Examination, a student must appear in Mid Semester Examination and Internal Assessment.

Assessment:
