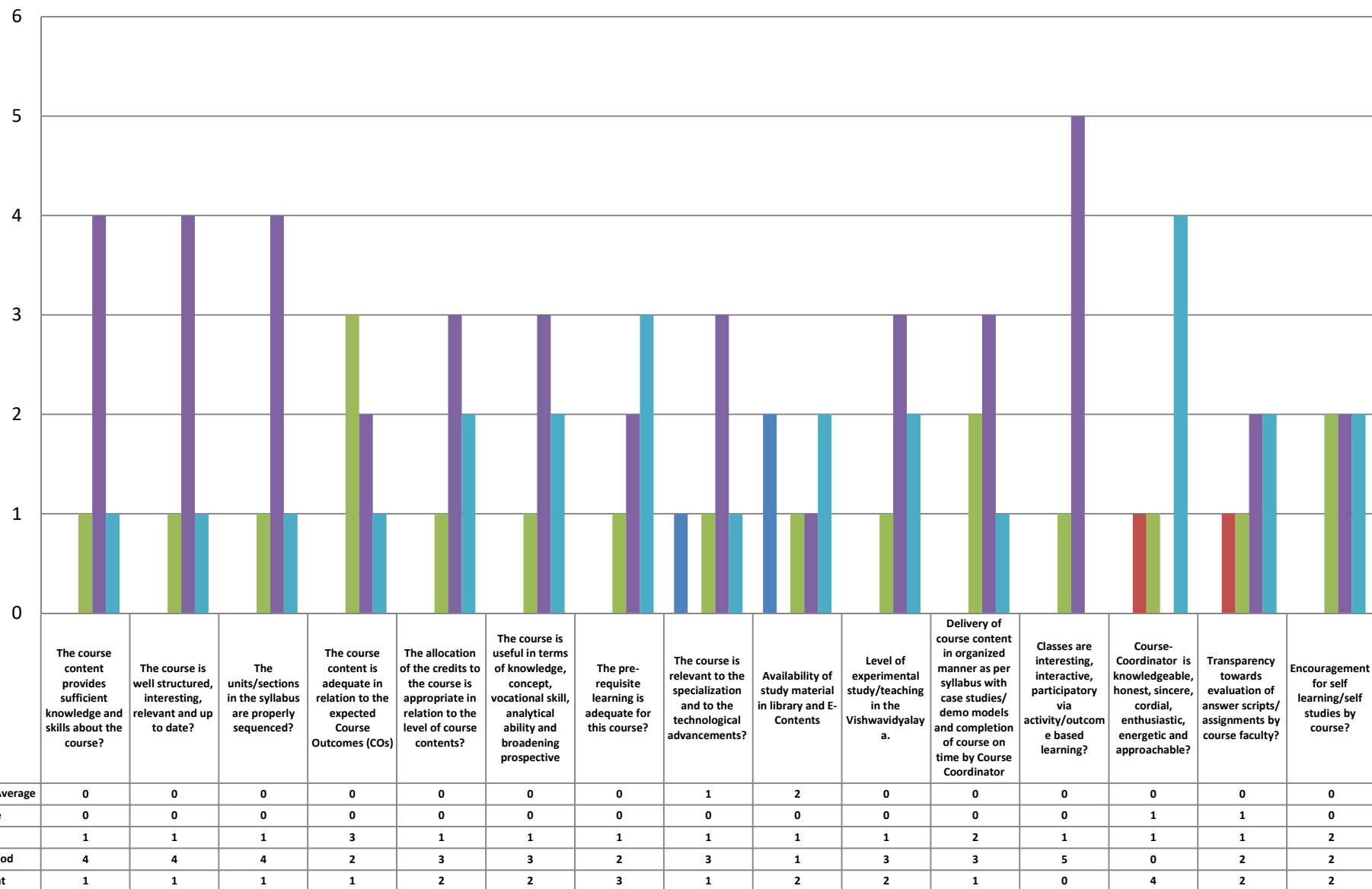

Q8. The course is relevant to the specialization and the technological achievements.

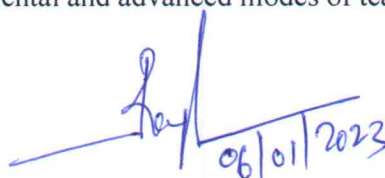
A8. More specialized and technologically advanced course contents are being introduced with upcoming sessions.

A13. Course coordinator is perfect according to maximum students with all the asked qualities.

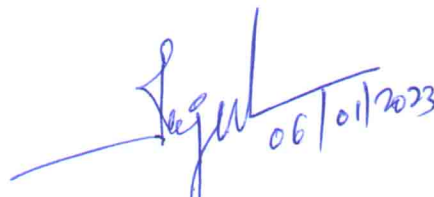
Q14. Transparency towards evaluation of answer scripts/ assignments by course faculty?
