At the outset, the convener of the APC, Prof. Naveen Kango, DoAA, welcomed Chairperson, all the esteemed Members and Special Invitees. Thereafter, the Agenda items were taken up for discussion.

APC:M:31:(01): Confirmation of Minutes of 30th Regular Meeting of the APC held on 16 August 2022 and 43rd to 46th Emergent Meetings of APC held on 30 June 2022, 06 October 2022, 13 January 2023 and 06 February 2023 respectively.

Resolution:- The APC after due deliberations confirmed its Minutes of 30th Regular Meeting held on 16 August 2022 and 43rd to 46th Emergent Meetings held on 30 June 2022, 06 October 2022, 13 January 2023, respectively.

APC:M:31:(02): To consider the recommendation of the DRC dated 09.03.2023 of Dept. of Pharmaceutical Sciences.

The Departmental Research Committee (DRC) of the Dept. of Pharmaceutical Science in its Meeting held on 09.03.2023 after considering the request of the candidate Ms. Monika Vishwakarma, Y20454001 resolved to change the supervisor Dr. Dharmendra Jain and allocate Prof. Vandana Soni as new supervisor. The BoS of the Department of Pharmacy in its Meeting held on 08.08.2022 resolved that Prof. Vandana Soni will be the Supervisor of Ms. Monika Vishwakarma.

Sh Akhand Sharma made a representation on 22.03.2023 that his pre-Ph.D. submission seminar was conducted on 22.02.2022 and he has also deposited all the requisite fees before 31.12.2022, but, due to the sudden serious illness of his father (who suffered from a brain stroke), he could not complete his thesis work and submit it by 31.12.2022. It is informed to the Council that Sh Akhand Sharma was registered as a Research Scholar on 01.09.2016 and a maximum period of 6 years for submission of thesis completed on 30.08.2022. As per UGC Notice dated 17.05.2022, an extension of 6 months was also granted to the students on the recommendation of the supervisor and Head of the Department for submission of the thesis. That period also expired on 31.12.2022. The documents related to the serious ailment of his father are annexed with his representation. As per clause 33 of Ordinance 23(A) governing Ph.D. Program, in special circumstances, any relaxation to the Ph.D. Program by Academic Program Committee/ Academic Council/ Executive Council/ Vice-Chancellor may be made subject to fulfillment of "University Grants

Commission, (Minimum Standards and Procedure for Awards of M.Phil./ Ph.D. Degree) Regulations, 2016."

Resolution:- The APC after due deliberations resolved that the Research Scholar may re-register as envisaged in UGC (Minimum Standards & Procedures for Award of Ph.D. Degree), Regulations, 2022 and submit the thesis accordingly.

The Controller of Examinations, CU Punjab, Bhatinda vide his letter No.CUPB/CoE/2022-23/888 dated 19.01.2023 considering her request asked her to submit the following documents:

- 1. No Objection Certificate from Dr. Harisingh Gour V.V. Sagar, M.P.
- 2. Consent of her Supervisor.
- 3. No Objection Certificate from funding agency.

A copy of the said letter has also been endorsed to the Registrar of the Vishwavidyalaya. The Research Scholar Ms. Nidhi Dinkar has been pursuing Ph.D. under the supervision of Dr. Neelu Rawat since 20.01.2022. Dr. Neelu Rawat has now joined as Associate Professor at CU Punjab. The Research Scholar has submitted that her marriage has been fixed in Chandigarh. For this reason, she intends to pursue her Ph.D. from CU Punjab. Although there is no specific provision either in University Ordinance or UGC Regulations to provide NoC for such purpose yet there is a provision in the University Ordinance 23(A), UGC Regulations 2016, and UGC Regulations 2022 governing Ph.D. Program, which stipulates as under.

"In case of reallocation of a female Ph.D. Scholar due to marriage or otherwise, the research data shall be allowed to be transferred to the Higher Educational Institution to which the Scholar intends to relocate provided all the other conditions of these Regulations are followed and the research work does not pertain to the project sanctioned to the parent Institution/ Supervisor by any funding agency. In the instant case, the research work does not pertain to the project sanctioned to the Vishwavidyalaya. The HoD, Dept. of Sociology, and Dr. Neelu Rawat have already given no objection in this case.

APC:M:31:(05): To consider the issue of allocation of Ph.D. supervisors for the students already admitted to Ph.D. Program in Academic Session 2021-22.

> The Head & Dean, Department & School of Law vide his note dated 02.02.2023 submitted that Dr. Ruchi Rani Singh, Assistant Professor, Dept. of Law under whose supervision 03 Research Scholars were allocated resigned from the University and joined the University of Delhi. After leaving the Department by her, there are only 02 eligible supervisors namely Dr. Anupama Pandit Saxena and Dr. Vikash Agrawal. These 02 supervisors have already 03 Research Scholars and if they are allocated the Scholars of Dr. Ruchi Rani Singh, then one teacher will have 05 Research Scholars under him/her. Ordinance 23(A) permits only 04 candidates under 01 Assistant Professor. In this regard, it is informed to the APC that it is true that as per the aforesaid clause of Ordinance 23(A), the maximum number of Ph.D. Scholars allocated to a Research Supervisor/ Co-Supervisor at any given point in time shall be as follows:

- Professor 08 (Eight)
- ii. Associate Professor - 06 (Six)
- iii. Assistant Professor - 04 (four)

But, here is a peculiar situation. The students already admitted have to be allocated Research Supervisors from amongst the teachers available in the Department who are eligible to be supervisors. Since, at present, there are only 02 Assistant Professors in the Department of Law who are eligible to be supervisors and the total number of Research Scholars is 09, hence, one Assistant Professor may be allocated 04 and another 05 Research Scholars. Even in the past, to deal with such a situation a teacher has been allocated Research Scholars above and over the maximum limit.

Resolution:- The APC after due deliberations resolved to approve the proposal under the captioned agenda. The APC further resolved that the allocation of supervisors may be done by the BoS of the Department of Law.
