SANCTION ORDER

Sanction of the Indian Council of Philosophical Research is hereby accorded for the award of General Fellowship to **Dr. SHALIGRAM AHIRBAR** to work on the Research Project entitled "आधुनिक भारतीय चिन्तन में नव्यवेदान्त : एक समालोचनात्मक अध्ययन (विवेकानंद एवं रामतीर्थ के विशेष संदर्भ में)" for two years, with effect from 01.10.2016 to 30.09.2018 as per the terms and conditions of fellowship stipulated in the Council's letter of even number dated 30.09.2016 to him.

Sanction of the Indian Council of Philosophical Research is hereby accorded for release of first installment of fellowship grant amounting to Rs. 1,84,800/- (Rupees One Lakh Eighty Four Thousand Eight Hundred only) for the period from 1.10.2016 to 31.03.2017 to **Dr. SHALIGRAM AHIRBAR**. The fellowship will be payable to her/him on pro-rata basis after the last working day of the respective months @ Rs. 30,800/- p.m. The actual release of fellowship depends upon availability of funds with ICPR and timely clearance of grant from the Ministry.

The Fellow has to submit the Monthly Attendance Reports (MARs) within 10th of the subsequent months for release of monthly fellowship. The fellowship for subsequent 2nd, 3rd and 4th installments will be sanctioned on submission of satisfactory six monthly Progress Reports (SMPRs) at the end of 1st, 2nd, and 3rd installment periods, respectively. Each SMPR should show continuous progress consistent with the planning for submission of the final manuscript at the end of two years tenure of the fellowship.

As per the Governing Body decision dated 01.07.2016 vide item no. 6 state that "The time available for the Fellows under the ICPR fellowship will be only 3 years to submit their final manuscript from the date of their joining failing which they may have to forgo the further dues from the Council." However, 25% of last installment of the fellowship will be put on hold till the final manuscript is received.

The amount sanctioned herein would be paid on pro-rata basis to **Dr. SHALIGRAM AHIRBAR** through Bank transfer to his/her A/c No. **0297101021579** at Canara Bank, Gujarati Bazar, Sagar, M.P.-470002 (IFS Code: CNRB0000297), and debitible to the account head Group-D, D-XI- (A) SC (Plan) General Fellowship of the budget allocation of the Council for the current financial year.
