

Sanction of Science and Engineering Research Board (SERB) is hereby accorded to the above mentioned project at a total cost of Rs. 4322560/- (Rs. Forty Three Lakh Twenty Two Thousand Five Hundred and Sixty Only) with break-up of Rs. 2000000/- under Capital (Non-recurring) head and Rs. 2322560/- under General (Recurring) head for a duration of Three years. 9. The sanctioned equipment would be procured as per GFR and its disposal of the same would be done with prior approval of SERB.
