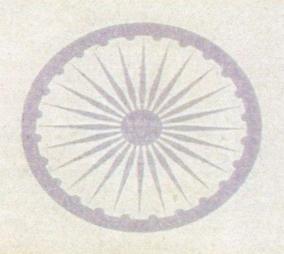

BRICS countries' economies have grown stably in last one decade. Before began of recession in the world, China, India, Russia, Brazil and South Africa's economies have grown at the rate of 14.2 percent, 10.1 percent, 8.5 percent, 6.1 percent, 5.5 percent in 2007. During 2006-08, the average growth rate of China, India, Russia, Brazil and South Africa's economies were around 12 percent, 8.5 percent, 7.3 percent, 5.1 percent, and 4.9 percent respectively (According to UNCTAD, Trade and Development Report 2014).

While the recession has badly affected Russian, Brazilian and South African economies and have experienced negative GDP growth in 2009. Their GDP growth rate has fallen at rate -7.8 percent, -0.3 percent, -1.5 percent (2009) respectively. Chinese and Indian GDP growth have been less affected relatively and maintained 9.2 and 5.0 percent in 2009. Despite the recession in the world economies, Chinese and Indian economies have maintained the positive growth, which have strong role in leading the BRICS economic and trade cooperation. While Indian economy has maintained around 4-6 percent annual growth, Chinese economy has experienced around 7-9 percent growth, annually, during 2009-14 (According to UNCTAD, Trade and Development Report 2014).

In BRICS grouping, India has dominance position in IT sector, China has leading role in world transport, infrastructure area. Russia is rich in energy sector and South Africa has a leading role in tourism and financial sector. Brazil is an agricultural powerhouse and has also advancement in retail sector. China with the trillion dollars in hard

currency reserve and India's growing in IT sector, both developing blue water navies are opening the way for a multi polarera in world politics (Bandyopadhyay, 2012). They have also intra-bilateral and trade agreement with regional groups like MERCOSUR, SACU etc.

Indian foreign policy has long been guided by the imperative of developing more prominent international role. It has been associated with ambitious to secure favorable external conditions for economic and trade development and to secure India's recognition as a significant international player at regional and multilateral level. India has gained economic stability with dynamic industrial and service sector, strong democratic institution and its active involvement within international institutions made its status as a rising power. Its foreign policy goals are to build bilateral, regional and global alliances to expand its influence in international politics. BRICS coalition provides one of the important forums for India to put its concern about global issues.

Emerging powers prefer to solve issues through negotiations and building consensus and exert their influence at multilateral level. Because they are not capable to impose their agendas, visions due to

dominance of great powers. Therefore, multilateralism and consensus building are major strategies of their foreign policies in dealing with developed countries. Their roles are deal maker in the presence of great powers. Countries like South Africa, Brazil and India perceived themselves as a bridge builder between the developed and developing states. Their diplomacy attached special significance to multilateral coalition building among states and non-states actors. The objectives are to strengthen the rule based system and provide opportunities for smaller states to participate on equal footing on the world stage (Leith & Pretorius, 2009; 348-49).

Whereas, roles and the functions of traditional middle powers were concerned on world scale and they were subordinate to or in the direct presence of the superpowers and as interlocutors bridging the space between the powerful and powerless in international system (Schoeman, 2000; 2-3).

But emerging middle powers are part of their regions and share the responsibilities to support the least developing countries, which make differences their roles and functions from the traditional middle powers. Behaviorally, emerging powers follow multilateralism in international politics and are characterized as stabilizer, conflict reductionist, willing to comprise to take benefits and committed to promote security and order in world system. Emerging powers, dictated by their semi-peripheral status, compared with the core position of traditional middle powers in the global economy, favor greater reform to global rules and structures. The solidarity shown by developing countries within several fora provides opportunities to emerging middle powers to fulfill leadership role and to gain access to the market of developing states masked by rhetorical references to South-South cooperation and third world solidarity (Jordaan, 2003; 176).

Their regional positions provide strength to play vital role in shaping agendas of world politics within multilateral institutions. These emerging powers serve as interlocutor between the regional and great powers. India has been recognized as an emerging power on the basis of its roles, which it has played in peace making, stability and democracy. It qualifies the behavior of an emerging power. Its emerging power status is one of the major determinant factors in the formation of collations like IBSA and BRICS. India being as an

emerging power is aspiring for larger role in international politics aligning with likeminded countries- Brazil, South Africa. It has followed soft balancing, which is also an important strategy of emerging power state in international politics.

Forum like BRICS, IBSA provide a platform for political and diplomatic consultation to the rising powers. The formation of BRICS Forum has facilitated India a new platform to deepen their political, diplomatic coordination and enhanced economic collaboration. The enhanced interactions through BRICS forum are complementing to deepen their relations at inter-regional and multilateral level. It also, serves as platform to share their views, polices in order to make common stands on several important issues at multilateral fora. The main political objectives of BRICS Forum are to enhance political consultation and coordination between partners on global issues such as international terrorism, peaceful resolution of conflicts and sustainable development.

2. BRICS countries' hegemonic position in their Regions;

One of the important determining factors of BRICS cooperation is regional dominance of its partners. The regionalism has provided new opportunities for regional hegemons like India, South Africa, Brazil, China to solidify their hold on their near abroad through the pursuit of regional trading arrangements such as Mercosur, SADC, SAARC, SCO and the consolidation of their leading economic position over the region in institutionalized form provides a springboard for global action (Alden & Viera, 2005; 1080). While India, South Africa, Brazil have hegemonic position in Southern Africa, Latin America and South Asia, China has dominance position in Asia. Russia is insisting to revise the Eurasian Economic and trade cooperation. China is insisting to develop silk trade route. economic power in to greater geopolitical influence. Its main role seems to become a counterbalance of the power axis on the world scene with a broader economic and political goal (Arkhangelskaya, 2012).

These coalitions and forums, alliances are instrumental in strengthening their image and strength in influencing international system. These emerging powers are keen to get space in international power arrangement system. The world order is in transition, which is passing from uni-polar world towards multi-polar. Yet it is not completely settled down. There is power shifting from the Western to Eastern world in international politics. The new centers of power are emerging from Southern world. The concept and the emerging reality of BRICS- Brazil, Russia, India, China, and South Africa- as a geopolitical and economic grouping of nations introduces a new dynamic to global governance and economic relations (Grodhan, 2011; 31).

In the views of Shaw, Cooper et al, a post-bipolar triad of distinctive state types, which is gradually evolving- first world club around the OECD, second tier of emerging economies and third extensive and heterogeneous third world, are producing a new three world structure. The emerging economies are aspiring towards the top tier of the global architecture (Shaw and Antkiewics et al. 2007; 1256). In the process of power shifting, the behavior and roles of Southern emerging powers are getting crucial role in reshaping the global order. Countries like South Africa, Brazil, and India occupy middle position between center and periphery. Their behavior, strategy are centered on middle power strategy in direction of creating multi-polar world. Their strategies are to build regional power pole of the new emerging world order, since their region serves as regional power base in acting autonomously in international politics.

While Indian government has actively participated in all six BIRCS summits and signed several MoUs with other partners, it has also engaged with BRICS countries at multi-lateral level regarding the regional and global issues.

3.1 India's Engagements with BRICS countries at Multi-Lateral Fora

India is engaging with emerging powers at multilateral fora, due to their similar policies, stands and sharing interests on various issues. Indian participation in groups and forums like BRICS and IBSA, have enhanced their political and diplomatic interactions within international institutions. These Forums have set up a political framework not only to foster the cooperation among them but also sustaining a regular political dialogue geared to coordinating positions and developing joint approaches to key global issues and to the development challenges (Vaz., 2010; 26).

3.1.1 Cooperation within World Trade Organization;

The homogenization and policy convergence by developing countries around the democratic norms, their dissatisfaction with developed countries' discriminatory policies and the willingness to act collectively in favor of developing countries, have brought India, South Africa, Brazil, China and Russia together within multilateral institutions. Following multilateralism approach in the foreign policies, their strategies are to build coalitions, alliances with those

So, there is need to reform and make them more transparent and rule based so that developing countries can maximize their interests. But lack of coordination is visible between BRICS partners on some issues like UN Security Council Reform, which reduces their bargaining power on multi-lateral fora. While South Africa is not willing to join G-4 Group following the mandate of African Union, China is not willing to support India's candidacy for UN Security Council's permanent seat.

4. Challenges;

There are several issues, concerns, inequalities and differences among BRICS' partners, which are obstacles in enhancing economic trade collaborations and engagements with each other's. Low ranking of BRICS countries in Doing Business Report are major problems in creating favorable and conductive environment for enhancing trade and investment activities in these countries. While China has 90th rank, India, Brazil, South Africa and Russia have142fh, 120th, 42th and 62th rank respectively (Doing Business World Bank Report, 2015). No BRICS country is in top 10 ranking in doing business world report which shows not good condition for doing business and investments. Several issues like custom duty and tariff issues are matter of concerns in promoting intra BRICS economic and trade cooperation.

4.1 Heterogeneous Nature of BRICS Group;

BRICS coalition is known for its diverse nature. While India, Brazil and South Africa are democracies, China's political system is based on one party rule and Russian Federation is based on highly centralized Presidential System. BRICS countries have inequality, wide spread poverty, health issues etc. Russia and Brazil are the most urbanized states among BRICS, China, India and South Africa still have to complete a long journey in term of urbanization, health care and poverty reduction. BRICS countries need to develop mechanism and share experiences in meeting social challenges like poverty, to tackle health care issues, education and other social inequality which are affecting their development. There is need to develop collaboration among them in skill development programmes, initiatives, sharing technical advancement, medical reform for social development.

4.2 Bilateral differences

Bilateral differences in the BRICS group are obstacles in developing trade and making political consensus on several contentious regional and global issues. While Clash of Political and geopolitical interests, boundary dispute between India and China are bone of contentious in BRICS. There is also tough competition between China and India, particularly for catching market and energy resources in African continent and South East Asian countries. There is also dissatisfaction in Russian and Chinese's bilateral trade structure.

Conclusion;

Thus, the emerging power status is one of the driving forces in formation of BRICS coalition. The BRICS coalition is based on economic concept of rising economies. Due to a powerful coalition,
