- > Should establish and enforce ethical guidelines, screen for plagiarism, and ensure transparent peer review.
- > Should require adherence to ethical standards as a condition of funding and investigate allegations of misconduct.

Attendees learned how experienced researchers can mentor junior colleagues to instill ethical values and practices. The lecture encouraged open access publishing and data sharing to enhance transparency and accountability.
