The session commenced with a cordial reception of our esteemed guest speaker, Prof. Pratap Rao Kadam, by Prof. J.K. Jain, the Moderator and Head of the Department of Commerce. Prof. Jain extended his greetings to all participants and provided a brief overview of the lecture's agenda, highlighting the significant elements and strategies required to manage and maintain a congenial work environment.

Prof. Kadam, the Resource Person, commenced the lecture by providing an overview of the fundamental principles of creating a harmonious workplace, emphasizing their foundational importance in fostering a productive and positive professional atmosphere. - Conflict of Interest: The lecture discussed the need for transparency in disclosing financial, personal, or professional conflicts of interest, aligning with the ethical standards highlighted earlier. Maintaining objectivity and integrity was deemed critical.

The lecture also provided attendees with key takeaways for effective workplace management, which paralleled the principles emphasized in research ethics:

Adherence to Ethical Guidelines: Much like in research, attendees were reminded of the importance of adhering to ethical guidelines and principles, ensuring a fair and just workplace.

Fostering an Ethical Culture: The lecture stressed the need for organizations to foster an ethical work culture, akin to fostering ethical research practices. Providing resources and training was deemed vital.

Establishing Ethical Guidelines: Similarly, organizations were encouraged to establish and enforce ethical guidelines to maintain integrity, much like journals and publishers.

Transparency and Peer Review: Attendees were reminded of the importance of transparency, as transparency in research was discussed. Encouraging open communication and peer review within the organization was suggested.

Mentoring and Development: The lecture encouraged experienced employees to mentor junior colleagues, instilling ethical values and practices, mirroring the guidance provided in research ethics. Openness and Accountability: Attendees were urged to embrace open access communication and data sharing within the organization, aligning with the principles of transparency and accountability.

As the session came to a close, attendees departed with not only a deeper understanding of congenial work environment but also with cherished memories of an insightful and inspiring experience. The Coordinator, Dr. Rupali Saini, Assistant Professor, virtually honored Prof. Kadam for sharing his expertise and wisdom with all participants. Further, she extended her heartfelt thanks to everyone for joining the digital assembly.
