The revised minimum eligibility for Admission in NCET-ITEP based B.Sc.-B.Ed., B.A.-B.Ed., B.Com.-B.Ed. programs are as under and the same shall be applied during subsequent counsellings:

Minimum Eligibility for ITEP

1. ITEP B.A. B.Ed. (Secondary Stage) is a dual major degree programme, with one major in Education and another Major in seven different disciplines namely Hindi, English, Sanskrit, Geography, History, Political Science and Economics. The followings are the criteria of admission at Doctor Harisingh Gour Vishwavidyalaya, Sagar into ITEP B.A.-B.Ed. (Secondary Stage):

- ✓ As specified on page no. 12 of The Gazette of India: Extraordinary, Part III-Section 4-National Council for Teacher Education Notification, New Delhi, 26th October 2021.
 - a) Candidates with at least fifty percent marks in Senior Secondary or 10+2 examinations or its equivalent (under 5+3+3+4) from a recognized board in any stream/discipline are eligible for admission.
 - b) The relaxation in percentage of marks in the Senior Secondary or 10+2 examinations or its equivalent examination (under 5+3+3+4) and in the reservation for Scheduled Castes or Scheduled Tribes or Other Backward Class or Persons with Disabilities or Economically Weaker Section and any other categories shall be as per the rules of the Central Government or State Government or Union Territory Administration, wherever applicable.
- ✓ Admission to the programme will be through the National Common Entrance Test (NCET) conducted by the National Testing Agency.
- ✓ Candidate must have appeared in all the 7 subjects in National Common Entrance Test 2025 (NCET-2025).

2. ITEP B.Com. B.Ed. (Secondary Stage) is a dual major degree programme, with one major in Education and another Major in two different disciplines namely Accountancy and Business Studies. The followings are the criteria of admission at Doctor Harisingh Gour Vishwavidyalaya, Sagar into ITEP B.Com. B.Ed. (Secondary Stage):

- ✓ As specified on page no. 12 of The Gazette of India: Extraordinary, Part III-Section 4-National Council for Teacher Education Notification, New Delhi, 26th October 2021.
 - a) Candidates with at least fifty percent marks in Senior Secondary or 10+2 examinations or its equivalent (under 5+3+3+4) from a recognized board with
 - ✓ Commerce/Business Studies/ Economics/Accountancy as compulsory subjects are eligible for admission are eligible for admission.
 - b) The relaxation in percentage of marks in the Senior Secondary or 10+2 examinations or its equivalent examination (under 5+3+3+4) and in the reservation for Scheduled Castes or Scheduled Tribes or Other Backward Class or Persons with Disabilities or Economically Weaker Section and any other categories shall be as per

the rules of the Central Government or State Government or Union Territory Administration, wherever applicable.

- ✓ Admission to the programme will be through the National Common Entrance Test (NCET) conducted by the National Testing Agency.
- ✓ Candidate must have appeared for the Business Studies, Accountancy, Economics/Business Economics tests as the domain subjects in the NCET-2025 conducted by the National Testing Agency (NTA).
- ✓ Candidate must have appeared in all the 7 subjects in National Common Entrance Test 2025 (NCET-2025).

3. ITEP B.Sc. B.Ed. (Secondary Stage) is a dual major programme, with one major in Education and another Major in five different disciplines namely Physics, Chemistry, Mathematics, Zoology and Botany. The followings are the criteria of admission at Doctor Harisingh Gour Vishwavidyalaya, Sagar into ITEP B.Sc. B.Ed. (Secondary Stage):

- ✓ As specified on page no. 12 of The Gazette of India: Extraordinary, Part III-Section 4-National Council for Teacher Education Notification, New Delhi, 26th October 2021.
 - a) Candidates with at least fifty percent marks in Senior Secondary or 10+2 examinations or its equivalent (under 5+3+3+4) from a recognized board with Physics, Chemistry, and Mathematics/ Biology as compulsory subjects are eligible for admission.
 - b) The relaxation in percentage of marks in the Senior Secondary or 10+2 examinations or its equivalent examination (under 5+3+3+4) and in the reservation for Scheduled Castes or Scheduled Tribes or Other Backward Class or Persons with Disabilities or Economically Weaker Section and any other categories shall be as per the rules of the Central Government or State Government or Union Territory Administration, wherever applicable.
- ✓ Admission to the programme will be through the National Common Entrance Test (NCET) conducted by the National Testing Agency.
- ✓ Candidate must have appeared for the Physics, Chemistry, and Mathematics/Biology tests as the domain subjects in the NCET 2025 conducted by the National Testing Agency (NTA).
- ✓ Candidate must have appeared in all the 7 subjects in National Common Entrance Test 2025 (NCET-2025).
